Letter from the Chairman, Aidie Jones



As the second year, since Lake District Mobility (LDM) was granted charitable status, draws to a close, it is important to reflect on our progress and achievements. All were made possible by our dedicated trustees, staff and volunteers.

Since the beginning of the reporting period, our team has been further strengthened by Chris MacLeod and Lorrainne Smyth joining our trustee board and Penny Swann being appointed as a fundraiser. This puts us in a strong position to keep the momentum going through the next few years.

Our partnerships with Countryside Mobility and Forestry England (formerly Forestry Commission) at Whinlatter Forest remain extremely positive. The combined launch of LDM and Whinlatter as our first hire site in May 2018 went extremely well and the Tramper at Whinlatter has benefited a significant number of people with limited mobility. With the Langdale Estate becoming our second hire site we have consolidated our operational function and begun to expand the scope of our provision.

Funding support from the Cumbria Community Foundation - United Utilities fund, Cumbria County Council, the Lake District National Park and other vital supporters made our launch possible. Now our private donor has really given us the financial backing and security over the next three years that we need to make the charity sustainable.

In conclusion, we have made a strong, well supported and well-planned start. I am certain that the charity will expand its provision and influence, and in so doing it will provide significant benefits to more and more people with limited mobility, both residents and visitors to the Lake District National Park.

Making the Outdoors Accessible

Our objective is the promotion of social inclusion among people with limited mobility, for the public benefit, by:

- Creating recreational opportunities through the provision of accessible facilities and specialist equipment.
- 2) Raising public awareness of the issues.

We work together with local outdoor sites, where our Tramper vehicles are situated and other local organisations. We use 100% of the donations we receive to:

- Assess and set up new Tramper access sites around the beautiful Lake District countryside.
- Manage and run our head office.
- Take up speaking invitations, where we spread the story and current developments of Lake District Mobility.
- Work in partnership with local decision makers, charities and businesses to improve accessibility across Cumbria.

Our values, as defined by staff, volunteers and Trustees, are:

- **Integrity:** We strive to be open and honest in all of our work. We support people from all walks of life and treat each person with dignity and acceptance.

Our Trustees

Aidie Jones continues as the chair and Anna Scamans as secretary. Chris MacLeod is now our treasurer and finance expert in our trustee team.

Our founding trustee and former treasurer, Ruth Kurkal, reached the end of her two-year term and has stepped down from the team of trustees. She is now helping us with site assessments and remains a keen supporter of our work. We are grateful to her for all her drive and hard work in setting up and developing the charity and ensuring its smooth operation.



Lorrainne Smyth, the Chief Executive of Voluntary ACTion Cumbria, has become our latest trustee. She has years of experience of working in and with the voluntary sector and small charities. We believe her input to be enormously beneficial to Lake District Mobility.

Lorrainne: "Having worked with LDM as it was forming, I was motivated to be involved as a volunteer because I believe that everybody can benefit from access to the great outdoors. LDM's work to provide simple, low cost access for families and others to be in the outdoors together is a small, but vital quality of life and wellbeing

ingredient. I have always been involved in volunteering with organisations that work with people with disabilities. I hope to bring my experience and skills from working with community organisations for over thirty years to the internal, governance and business planning elements of LDM's work."

Karen Smith moved on from her role as a Charity Administrator to the role of Trustee on 7/9/2019.

Our Staff

Julia Walker remains our Charity Development Manager, bringing new hire sites to the Lake District Mobility fold, building partnerships, raising our profile and influencing people across Cumbria.

Karen Smith has given Lake District Mobility invaluable support, first joining us as a volunteer in June 2018. Karen has a background in teaching and has worked as an Assistant Head and SINCO in a local school. Her experience, knowledge and skills were vital as she took up her role as a Charity Administrator in December 2018 and got to work in setting up and shaping our administrative functions. She stepped down from this role at the end of March 2019 and joined the board of trustees in September 2019. We are grateful for her support and hard work during all her time with us.

Penny Swann joined the team as a Fundraiser and Policy Co-ordinator on 1st April 2019. Trella Javanainen became Charity Administrator on 14th May 2019.

Trampers in the Lake District



In May 2018, Lake District Mobility was successful in launching its first Tramper at Whinlatter Forest Park, which is owned and operated by Forestry England. Forestry England and staff at Whinlatter have been very supportive and the scheme has proved to be very popular amongst visitors. Whinlatter has provided 186 Tramper hires during the reporting period.

Feedback from Tramper users has been very positive. Here are a few of their comments:

"Excellent experience. Enabled me to get out into terrain I couldn't possibly reach otherwise. Was emotionally moving."

"Came to use the Tramper all terrain wheelchair today for the 1st time with my mate who has not been able to get to these places for years & all I can say is fantastic thing to have for people with disabilities/difficulties, the staff were courteous, very helpful & gave you the time you needed, thank you very much as you helped give someone a great afternoon."

Staff at Whinlatter have found the scheme having a big impact on their offer to the public. Here are a few words from Nathan Fox, a Forest Ranger on the site:

"...one thing that has really became apparent to me that I very much under-estimated was the scale of the impact it has had on people's lives. I have done lots of briefs now, and all the people I have met who are using it have given me an insight into their backgrounds, and often health and mobility problems. One man told me how three years ago, he was cycling 150 miles and running 50 miles a week. Now he struggles to walk 150 meters, so for him to be able to access parts of the forest again which he never thought he would was a revelation for him. A lady told me she was left with (in her words) 'bad wiring' following a stroke, and her mobility was affected, so to see the joy on her face as she went off into the forest with her daughter, son and grandchildren took my breath away. It has been a good thing for us all having the Tramper available and up and running and part of our offer, but by far the most important benefit has been on the positive wellbeing of its users."

During the reporting period, Langdale Leisure Limited joined the scheme and work began to prepare two routes in the Langdales for use by two Trampers.

Julia has continued to make contacts with several promising, potential partner sites across Cumbria, such as Calvert Trust and Grizedale Forest. It is anticipated that her work with these sites and others will lead to more Tramper access points becoming available across the county soon.

Working with North Yorkshire Moors National Park Authority



In the autumn of 2018, North Yorkshire Moors National Park Authority (NYMNPA) contacted Countryside Mobility for support in setting up access points in sites across the national park. According to LDM's partnership agreement with Countryside Mobility, North Yorkshire is within our catchment area and we began working with NYMNPA. During the reporting period we assessed routes and facilities for Tramper access at Guisborough

Forest and Walkway, Ravenscar Visitor Centre (a National Trust Property) and Sutton Bank National Park Centre.

Lake District Mobility has set up a Managed Affiliated Site agreement (three-way lease agreement) with NYMNPA. Under this agreement, the NYMNPA will:

- Own and have responsibility for the Trampers.
- Promote the scheme through their own channels and platforms.
- Encourage other local outdoor attractions to consider offering a Tramper scheme.
- Cover the cost of punctures.

The hire sites, in turn, are responsible for the day to day running of the scheme. This includes:

- Producing maps.
- Ensuring staff is suitably trained to keep the Tramper, Tramper users and staff safe.
- Completing and submitting membership paperwork appropriately.

LDM is responsible for:

- Insuring the operation of the scheme.
- Co-ordinating the maintenance of and repairs to the Trampers.
- Undertaking the initial site and facilities assessments, risk assessments and staff training.
- Carrying out inspections and checks to ensure that the hire scheme is operating properly.
- Operating the membership scheme and publicising the scheme.

Remedial work is now underway to ensure the assessed routes are safe for Tramper users. This will be followed by staff training provided by LDM. The National Park Authority endeavours to be ready to launch the schemes by summer holidays.

Partnership working to meet our ambitions

As well as working towards opening up Tramper access routes, Julia has also been working with other partners to improve accessibility in the county in general.

The local plan is the strategic plan for development for the Lake District up to 2035. The aim of the plan is to produce a planning framework for the conservation of the landscape, provision of jobs, housing, facilities and infrastructure that the Lake District wants and needs. LDM is actively involved in giving input into the area of accessibility to ensure that within the policies and frameworks of the plan Lake District becomes a first class welcoming and accessible place for all.

During our talks and assessments, we encourage partners to become Changing Places.





Together with the Lake District National Park Authority and Cumbria Tourism, Julia has begun work to develop an accessibility guide and a map to Cumbria. This work is still underway.

During this reporting period, work also got underway to set up an annual "Access Lakes Conference". The first conference, scheduled for 3rd December 2019, will empower large and small attractions and businesses in the Lake District to start the journey to become as accessible as possible and welcoming to everyone. Lake District Mobility is delivering the conference in partnership with The Lake District National Park Authority, Cumbria Tourism, National Trust, Langdale Leisure Ltd and Lakeland Arts.

Recognition



In recognition of "great and valuable services to the community" Lake District Mobility received The High Sheriff of Cumbria's award in March 2019.

The awards come from the High Sheriff's Crimebeat Fund which is managed by the Cumbria Community Foundation.

Reserves Policy

In the opinion of the trustees the reserves are satisfactory for the forthcoming year.

We continue to find and assess new sites in which to situate our Trampers and to make regular applications to potential funders.
